RULES & REGULATIONS

1. Only players registered with GSTTA for the year 2019 can participate in the Tournament.
2. All the matches will be played in accordance with the rules and regulations for State Ranking Tournaments adopted by GSTTA.
3. All entries must be submitted in the entry form attached mentioning the date of birth of player (Incomplete entry form will not be accepted). Entry fees are non-refundable. The Tournament / Technical Committee reserves the right to refuse any entry without assigning any reason.
4. **The Youth Boys & Girls** event shall be open only to players **born on or after 01.01.1999**.
The Junior Boys and Girls event shall be open only to players **born on or after 01.01.2002**.
The Sub-Junior Boys and Girls event shall be open only to players **born on or after 01.01.2005**.
The Cadet Boys and Girls event shall be open only to players **born on or after 01.01.2008**.
5. Players should bring Original Birth Certificate issued by Municipal Corporation / School for verification if required.
6. Tournament Committee / Technical Committee reserves the right to cancel an event, and to change the draw and timing of the matches, if required.
7. The regulations for alteration of the draw will inter-alia be according to the TTFI Regulations as adopted by GSTTA.
8. The Tournament will be played as per the latest rules and regulations for ranking Tournament as framed by GSTTA. The decision of the Tournament/ Technical Committee will be final and binding on all players.
9. Entries close on **27th August, 2019** for players and **at 12 Noon on 29th Aug., 2019** for District Associations.
10. **ITTF approved 3 Star STIGA Perform balls will be used in the Tournament.**
11. All official Communication/Draw shall be displayed at the venue before the start of tournament and that alone shall be the official communication in all respects. This Tournament will be treated as Ranking Tournament and Points shall be awarded as per GSTTA guidelines.
12. Seeding will be announced at the tournament venue through Open Draw (for Top-16 ranked players) system.
13. The matches will be played in two stages i.e. Stage-I – Round Robin and Stage-II – Knock Out. This is only applicable if the number of entries in a particular event is more than 32. If not, then there will be Knock Out stage only.

14. The Cadet and Sub-Junior players shall be allowed to play only in the immediate next higher event but however, Top-16 Ranked Cadet/Sub-Junior player will be allowed to play in 2 next higher events. If a Cadet player is ranked in Top-8 in Junior category then, he/she is eligible to play in Youth category and if a Sub-Junior player is ranked in Top-8 in Youth Category then, he/she is eligible to play in the Senior Category.

15. The **Tentative Schedule** will be as follows :

Day-1	4th Sept.	Mens, Womens, Youth Boys & Girls Qualifying Rounds and Main Draw
Day-2	5th Sept.	Junior Boys & Girls Qualifying Rounds and Main Draw
Day-3	6th Sept.	Sub-Junior Boys & Girls Qualifying Rounds & Main Draw
Day-4	7th Sept.	Cadet Boys & Girls Qualifying Rounds and Main Draw
Day-5	8th Sept.	All remaining matches followed by closing ceremony

Final Schedule will be announced and declared after closing date of entries.

17. The participating players should compulsorily wear shoes with Non-Marking sole in the Field Of Play/Arena during matches as the flooring of the hall is synthetic.

18. All the participating players should have registered with GSTTA for their entries to be accepted. Players should pay a registration fee of Rs. 200/- towards registration fee for the year 2019 along with the entry fees in the first tournament they play in the calendar year.

19. Payment of Entry Fees : District Associations should ensure that all players pay the entry fees as failing to do so will result in the player's name being deleted from the system after the deadline. This is as per the decision taken at the AGM of GSTTA.
20. All players will have to make their own arrangement for Lodging and Boarding.
21. By entering into an event, players agree to abide by all rules and regulations of GSTTA and the Organizing Committee. All associations and individual players agree to be under the auspices of the GSTTA and its agents in all matters concerning television coverage, video, internet, webcasting, motion picture coverage, and photographic coverage of any kind. Participants release all rights or rights held by their agents or sponsors, in all matters relating to television and webcasting coverage, video and motion picture coverage and photographic coverage of any kind. A participant's refusal to the above listed coverage may attract suspension or dismissal from the competition.
22. Any violation of rules/indiscipline by players, players coach, player's parents / guardian can result in immediate dismissal from the tournament
23. The decision of Tournament/Technical Committee shall be final in all matters connected with the tournament.
